

## **CO ORDINATORS MEETING**

**TUESDAY 2 AUGUST 2011**

### **AUSTRALIA ROOM**

Meeting opened at 6.40pm.

Rebekah welcomed and thanked Co Coordinators for attending the meeting and read through the attached report supplied by HACT.

Co-ordinators were handed the Team Photo envelopes and Sportingpulse Team Lists.

#### **COMPETITION ISSUES:**

##### Sportingpulse Eligibility Report

Rebekah explained the process required to ensure Sportingpulse/HACT had the correct team lists for the final series. Clubs present were given Sportingpulse team lists for checking against club team lists and Co Coordinators were asked to advise HACT of any errors to ensure their lists are correct for the final series. It is up to the discretion of HACT to decide whether fines should be imposed, as per the By-Laws, if information on Sportingpulse is found to be incorrect.

Chris Flaherty requested that the accurate tables re: percentages be ready for clubs as soon as possible so they knew where they sit on the competition ladder.

#### **MISSED UMPIRING REPORT:**

Anne Sutherland brought up the financial burden on clubs paying for umpires “twice” when games are iced out and then played on a Monday night. Again it was suggested that 8am games not be scheduled in the 2012 competition.

**UMPIRING NOMINATIONS FOR FINALS:**

Clubs were asked to nominate umpires for the final series with HACT as soon as possible.

**INDOOR COMPETITION:**

Chris raised concerns that the \$500 non refundable nomination fee to register a team in the 2011/2012 Indoor Competition may result in clubs not nominating and no competition going ahead.

**UMPIRING SURVEY AND FORUM**

Co Coordinators were asked to encourage their members to participate in this survey to assist with plans for the 2012 season.

**GENERAL BUSINESS:**Dual Registration

Members raised concerns of girls playing for one club in the girl's competition and another in the boy's competition. As the Junior Competition is one competition this is against By-Law 8.1 and those girls should not be allow to play in any further games. Rebekah agreed to ask the Competitions Committee for a ruling on this matter as the girls had already played most of the season before this was picked up.

Kicking Back

Members were asked to remind all club members that there no provision for a kicking back in the Junior Competition and if a team cannot field a fully kitted goalie that team forfeits the match. This should be recorded on the match card.
