Overview:

The Indoor Hockey format consists of two teams competing against each other with six players per team, including a goal keeper. The players can make an unlimited amount of substitutions from a maximum twelve players on the team. The surface is a maximum of 44m by 22m and features side boards. This keeps the ball in play, making indoor hockey a fast flowing and exciting game.

In Indoor Hockey the ball may only be pushed or flicked but not hit. Except for a shot at goal, it may only be played along the ground. Players skillfully push, pass and dribble the ball. Players cannot dive on the ground or slide tackle. The goal keeper is the only player who can play the ball while on the ground.

Matches are played in quarters.

Hockey ACT conducts Senior Indoor competitions, held in the R. J. Brown Indoor Stadium at the National Hockey Centre Lyneham. Games are held on Monday, Tuesday, Wednesday, Thursday and Sunday evenings.



Senior Competition Format


Senior Competitions play 10 rounds and two finals weeks (Semi and Grand Finals) for the top ranked teams. The competition runs from October 2023 through to March 2024. Competitions have a maximum number of teams able to participate. This is due to the availability of indoor facilities.

Overflow teams will only be permitted if spare timeslots exist within field availabilities. The use of different nights and locations will be considered if necessary.

To allow for more teams and an earlier finish time, Thursday Women Div 2 will be played on side by side courts (30x21m - Red), whilst all other competitions will be played on single court (42x22m - Black) as shown in the diagram below. These are both regulation size courts.

All players in the indoor competition will be required to *Renew* their Hockey Australia insurance Levy prior to their first game in 2024.

Nomination Information

Hockey ACT is accepting two types of nominations for the 2023-2024 Indoor Season.

Affiliated Clubs

These are HACT registered clubs who are set up in the Revolutionise database. Club teams will be given preference over individual teams if the competition becomes full.

Individual Members

Individual member nominated teams will be charged a \$50 administration fee to cover the cost of setting up that team in Revolutionise. They will also be required to pay 50% of the total season fees before commencing round one of the competition. Individual nominated teams uniforms must not clash with any particular club within the competition. To nominate a team as an individual please complete the **Indoor Season Individual Nominations - 23/24 Senior Competition** event.

Nomination Due Date

All Team Nominations are due 9am Monday 2nd October.

All Senior team nominations must be returned to the Hockey ACT membership coordinator by 9am Monday 9th October. This also includes the Men and Women's Supers Competition.

All team nominations must be accompanied by a team coordinator's email address and signature.

All team nominations that arrive past the due date will have a \$100 late fee applied to their invoice.

Acceptance of team nominations after the due date will be dependent on available positions.



Team Fees 23/24

For the 23/24 Season Team Nomination fees will be as below;

Senior Team Nomination Fee: \$1213 per team

Thursday Div 2 Team Nomination Fee: \$900 per team

Hockey ACT Umpire Fee (Supers & SL1 Nominations): **\$250 per team**

All Clubs/Teams will be invoiced on the 17th November, 2023. Clubs/Teams will be asked to pay 30 days from the date of invoice issue.

HA Levy Fees 23/24

Please note that members who have not played hockey in 2023 can pay a Summer Insurance Levy of \$22.50 (9 to 18) and \$27.50 (19 and over) that will cover members insurance until 31 December.

23/24 Indoor members fees will need to ensure they have paid their **2024 Junior/Senior HA levy** prior to their first returning match of the new year.



Additional Information

Umpires

All Super and SL1 teams must nominate a suitable umpire for their respective divisions. The umpire must nominate via the **23/24 Senior Umpire Nominations** via RevSport.

The Hockey ACT Umpiring and Technical Committee will consider all umpire nominations and if rejected the team/club must provide a suitable alternative.

Additional Grades

All other competition teams must acknowledge that their team will be rostered to umpire in each week that they play and failure to fulfil this umpiring duty will result in a financial penalty.

Missed Umpire Duty Penalties:

In any Hockey ACT indoor competition if an umpire, nominated or club based, does not fulfil their appointed duty the club/team will be fined \$50. The penalties for missed commitments have been changed to reflect the same process as the outdoor seasons.

Repeated missed duties may result in competition points being deducted. The umpire who fulfils the missed duty will be credited \$40. This will be paid to the umpires club at the conclusion of the competition. The remaining \$10 goes to HACTs umpire development program.

How To Nominate

Club Nomination & President Endorsement

Team Nominations will be made via RevSport this season. Club Presidents & delegates are asked to complete their nomination via RevSport via the **Indoor Season Club Nominations - 23/24 Senior Competition** event.

Team Delegate details

For each team nominated, clubs must provide a team delegate. This person will be contacted directly with matters relating to this team. Please ensure you purchase the relevant ticket for nomination as well as list the team delegate for your team. Clubs are required to nominate a colour of the uniform they will be wearing. All players on the team are required to wear the same colour shirt and shorts. Uniform colour will be subject to approval prior to the indoor season.

Individual Team Nominations

This form should be used to nominate a team that is **not** affiliated with an established Hockey ACT club. Teams nominated via this method must also pay a \$50 administration fee which will cover the associated costs of establishing a new team in RevSport.

Team Delegates are asked to complete their nomination via RevSport via the **Indoor Season Individual Nominations - 23/24 Senior Competition** event. Please ensure you purchase the relevant ticket for nomination as well as list the team coordinator for your team.
